Summer Bulls Contest 2025

Live Trading Contest – Organized by CMS Prime

1. General Overview

The Summer Bulls Contest 2025 is a live trading contest hosted by CMS Prime, designed to promote competitive and skill-based trading in Forex and Gold markets. The contest runs over a defined period and rewards top performers with substantial cash prizes and trading benefits.

2. Eligibility

The contest is open to individuals aged 18 and above who hold a valid trading account under CMS Prime.

Eligible participants include **new clients, existing clients, and Introducing Brokers (IBs)**, provided they meet the following requirements:

- Complete the contest registration process.
- Fund their account with a minimum deposit of \$250.

Employees of CMS Prime, affiliated partners, agents, and their direct family members are not eligible to participate.

Each participant is permitted to enter the contest with only one (1) account.

3. Registration

- Registration for the contest opens on July 17th, 2025 and closes at **23:59 GMT on July 31st, 2025**.
 - To qualify:
 - Participants must submit a valid registration through the official contest landing page.
 - Deposit a minimum of \$250 into the designated trading account.
 - Accounts that do not meet the deposit requirement will remain in “read-only” mode and cannot participate.

4. Contest Period

- **Trading Period:** August 1, 2025 – August 14, 11:59 GMT, 2025 (2 weeks)
 - **Registration Period:** 2 weeks prior to the trading start date on July 17, 2025 until July 31, 2025

5. Trading Rules

- **Trading Instruments:** Forex Pairs and Gold (XAU/USD) only.
- **Leverage:** Starts at 1:100
- **Minimum Trading Volume:** 5 standard lots must be traded during the contest period to be eligible for prizes.

- A minimum of **5 separate trades** must be placed.
 - Trading is allowed only on the contest-designated platform.
 - Automated trading (EAs) not allowed.
 - Scalping, hedging, and swing trading are allowed provided they comply with platform rules.

6. Account Conditions

- The trading account will be **read-only** until the minimum deposit is received.
 - After deposit confirmation, the account will be activated for trading within the contest period.
 - Withdrawals are strictly prohibited during the contest. Any withdrawal will result in **automatic disqualification**.
 - After the contest ends, all participating accounts will be returned to “read-only” status.
 - Only **closed trades** will be considered in calculating performance and rankings. Any open trades at the time of contest completion will not be counted.

7. Evaluation & Scoring

- Winners will be determined based on **percentage profit growth**, calculated using the following formula:
$$[(\text{Final Equity} - \text{Initial Deposit}) / \text{Initial Deposit}] \times 100$$
 - This method ensures fairness by evaluating relative performance regardless of account size.
 - All evaluations will be conducted by CMS Prime using platform-verified data.
 - The leaderboard will be updated regularly throughout the contest.

8. Prizes

- **1st Place:**
 - \$50,000 Cash Prize
- **2nd Place:**
 - \$30,000 Cash Prize
- **3rd Place:**
 - \$20,000 Cash Prize
- **4th – 8th Place:**
 - \$10,000 Cash Prize each

Note: Prize payouts will be processed within 15 business days after verification of results and eligibility.

10. Disqualification Criteria

Participants will be disqualified for the following:

- Failure to meet minimum deposit or trading volume.
 - Use of multiple accounts or identity fraud.
 - Engaging in unethical or manipulative trading practices.
 - Attempting to exploit technical vulnerabilities or using banned EAs.
 - Requesting a withdrawal during the contest period.
 - Violating any of the contest rules or platform terms.
 - Any misuse of system or CMS Prime's Rules.

11. Rights & Limitations

- CMS Prime reserves the right to amend, cancel, or suspend the contest at any time without prior notice.
- The company reserves the right to disqualify any participant who violates the spirit or letter of these terms.
- All decisions made by CMS Prime regarding winner selection, rule enforcement, and dispute resolution are final and binding.
